#### New Business-

The License Board received a letter of correspondence from Mr. C's Taxi concerning an unlicensed taxi company that has been operating in the city for some time. The license board suggested that a certified letter be sent to the owner of the company and to notify the police department with a copy of the letter being sent.

In the Laconia Daily Sun newspaper members of the License Board read that an employee of a Licensed Pawnbroker in the City was arrested for receiving stolen property. In the Licensing Chapter 161-21 it states that the License Board shall suspend any license issued if someone is charged with violating the law while working under the license issued. Chief Erickson made a motion to suspend the Pawnbrokers License for a minimum of 45 days and at the next meeting the topic would be discussed again seconded by Chairman Rogato. The License Clerk will prepare the letter and the Laconia Police Department will serve the letter.

#### Old Business-

The License Clerk notified the License Board of Entertainment Licenses that have expired and she had sent out renewal letters and applications back in February and has received no responses by The Lobster Pound, Christmas Island, the VFW, Tavern 27, and the Heat Restaurant. Chief Erickson said to wait until next week to see if we get any applications in, and to let him know which ones are still expired and he will be contacting them.
