Old Business-

The License clerk will be submitting a memo to the City Council on their August 13, 2012 meeting requesting to add the definition of a Taxi Cab to Chapter 161 section 2 that will read:

Taxi Cab- Any motor vehicle, having a manufacturers rated capacity of not more than seven passengers, used in the call and demand transportation of passengers from within the limits of the city to a destination inside or outside of the city, for compensation to or from points chosen or designated by the passengers and not operated on a fixed schedule, between fixed termini, or any such vehicle leased or rented, or held for leasing or renting, with or without driver or operator. This definition shall not include: a motor vehicle subject to regulation by the Public Utilities Commission of the state; sightseeing buses or limousines designed to carry eight persons or more from a fixed place to places of interest about the city; or motor vehicles collecting fares by tickets or coupons sold for interstate transportation. Nor shall it include motor vehicles which provide service only to and from airports outside Laconia.

The board requested clarification on the underlined sentence from the City Attorney, the Clerk is going to contact her for clarification then once it is okayed by the board it will move to the City Council.
